- 5. All pets must be licensed by a county or state agency. Owner must provide proof of vaccinations.
- 6. Pets under 20 pounds must have a carrier or crate provided by the owner to go in the existing kennel enclosure.

**ANIMAL BOARDING ACKNOWLEDGEMENT OF RISK**

In consideration of the services provided by Morefield Village Kennel and Mesa Verde Company, its officers, agents, employees, and stockholders, and all other persons or entities associated with Morefield Village Kennel and Mesa Verde Company (collectively, "Mesa Verde"), I agree as follows:

I understand that while my pet is staying with Mesa Verde, he or she may come into contact with other pets and humans. Every effort will be made to ensure the safety of pets, but there are inherent risks involved with interactions between humans and dogs, as well as between dogs and other dogs, which may result in property damage or bodily injury, including but not limited to sickness or death; and there may be

other risks not known to me or Mesa Verde that are not readily foreseeable at this time. I understand that there are certain risks inherent in boarding my pet that cannot be eliminated. Mesa Verde believes it is important for me to know in advance what to expect and the potential risks, and that unknown risks may exist. In the event of an injury or illness, we will make every effort to contact you. If we are unable to reach you, your pet will be taken to our local veterinary clinic.

I fully accept responsibility for these inherent risks (which may or may not be specifically identified herein). My use of Mesa Verde is purely voluntary, and I elect to proceed hereunder in spite of and with full knowledge of the risks.

I have fully read, and understand and accept, the terms and conditions stated herein and acknowledge that this agreement will be effective and binding upon the parties during the entire period of participating in the said activity(s).
